

## FINAL TERMS



The Covered Bonds to be issued are expected to be rated "Aa3" by Moody's Investors Service España S.A. ("Moody's").

In addition, Moody's appends numerical modifiers 1, 2 and 3 to each generic rating classification from 'Aa' to 'Caa'; the modifier '3' indicates that the obligation ranks in the lower end of that generic rating category
